

BPDCompany Workshop Terms and Conditions

- Workshops run during School Holidays and Half Term Holidays.
- A Non refundable £30 deposit per student must be paid BEFORE the first date of the workshop to secure your place. The remaining fee must then be paid in full on the first day of the workshop.
- Payment Methods : Bank transfer, Cheque made payable to Bronia Gosling or Cash in an envelope with the students name on. For Bank details please info@bpdcompany.net
- Workshop Fess are per student and cannot be transferred over to friends or family.

Uniform/ Clothing Guidelines

- Leggings/Tracksuit bottoms or shorts (in very hot weather), Tshirt and trainers/ dance trainers/Jazz shoes. If a current student of BPDC Please wear your Uniform Tshirt. NO Ugg Boots, Jeggings, Jeans or sandals or school shoes please. Hair must be tied up or off of the face.
If the student is wearing inappropriate clothing or footwear the student may not be permitted to participate in the class.
- Students are responsible for their own property and bring items at their own risk. BPDCompany is not responsible for any lost, damaged or stolen items.
- ALL students must sign the Vibez studio waiver BEFORE entering the building. This can be found on our term information page.
- All Students **must** be signed in and out from the studio by a parent/carer or responsible adult. Students will not be allowed to leave the studio by themselves. The teacher must be informed if collection is undertaken by persons other than the child's parent or legal guardian. Written consent must be given for any students wanting to leave the studio without a parent/guardian.
- A certain amount of risk is carried by any physical activity. Students taking part in any of our classes or events run by BPDCompany do so at their own risk.
- To ensure the correct teaching of dance, physical contact may be necessary to guide students into the correct stance etc. We always make these corrections with due care and respect for dignity. Please contact Bron if you have any queries about this. (During COVID-19 procedures no contact will be given)
- Photographs and videos of students may be taken and used as promotional material on our website and/or social media. Please let us know, via email/your initial contact form if you prefer your child not be included.
- When you give us your details we promise to do our best to keep them secure. We may use your data to contact you in relation to;

- records of fees paid and outstanding (and any agreed payment terms)
